How does RNAPS operate?

The Society is a non-profit public company limited by guarantee and governed by a Board of Directors from which it receives its strategy and leadership. Subcommittees and Councils are appointed from members to coordinate various Society activities such as the weekly Launceston Esk Market. A major activity is the Royal Launceston Show for which the Board delegates responsibility to a Show Council consisting of up to 44 Show Councillors. Sub-committees of Show Council are appointed each year to co-ordinate specific sections of the Show (e.g. Beef Cattle, Animal Nursery etc).

You are supporting a longstanding contribution to showcasing rural industries within northern Tasmania, along with the other events and activities throughout the annual calendar.
